1. The Ministry of Energy and Mineral Development has allocated funds to be used for the procurement of Four (04) Global Positioning System (GPS) sets for the Petroleum Exploration and Production Department, Entebbe.
2. The Ministry invites sealed bids from eligible bidders for the supply of Two (2) Magnetometers.
3. Bidding will be conducted in accordance with the open international bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, and are open to all bidders from Uganda.
4. Interested eligible bidders may obtain further information from the Procurement and Disposal Unit (PDU) of the Ministry and inspect the bidding documents at the address given below at 7(a) from 0930 hrs to 1700 hrs on working days.
